General Aviation Handling

All fees stated in this schedule of fees are net. In addition, the applicable value added tax will be charged unless an exemption under the Value Added Tax Act applies.

Explanation

Mönchengladbach Airport (MGL) provides the following free standard services for handling on the main apron:

a) Standard service (free of charge)

- Crew assistance
- Use of the crew briefing and rest room, subject to availability
- Use of the crew lounge including WLAN
- Interface coordination with air traffic control and the authorities

Alternatively, you can book our Premium package. Please note the respective booking deadlines*. Handling takes place exclusively via the main apron (parking positions A1 to A6) and the terminal building.

Service infrastructure Charge

Explanation

The service infrastructure at Mönchengladbach Airport (MGL) is continuously improved and maintained at a high level in order to guarantee an appropriate level of service. To cover these costs, an infrastructure charge is levied on external users of the aerodrome, which is graduated according to the maximum take-off mass (MTOM) of the aircraft. For homebased aircraft, this fee is already in the parking or rental contract. It is the owner's responsibility to check this. In commercial air transport with passenger carriage, a passenger-dependent service infrastructure charge must also be paid, which is based on the number of passengers on board the aircraft at the time of take-off.

Freight handling

Explanation

The loading and unloading of freight onto an aircraft is subject to a charge and is calculated based on the specific weight of the freight. The order for this must be received by traffic management at least one hour before the estimated time of arrival (ETA) or the evening before. If a forklift truck is required for the loading and unloading process, this will be charged additionally.

Aircraft towing procedure

Explanation

We offer towing of your aircraft with landing gear (except helicopters on skids) to any location within the enclosed airfield area. This service is subject to a charge and is calculated per journey. During the towing process, your aircraft is insured by us against damage.

Washing area

Explanation

You can wash your aircraft yourself at the wash bay. Use is subject to a charge and the charge is based on the total take-off mass (MTOM) of your aircraft. The charge includes fresh and waste water, but not cleaning utensils.

Engine test stand according to BlmschG

Explanation

You can test combustion engines and power units on our engine test stand, which is approved in accordance with the BlmschG. Use must be agreed in advance with our traffic management. During use, the engine test stand must be secured with the existing folding signs, flashing lights and additional pylons. If the test stand is not properly secured during use, an increased usage fee will be charged.

Salvage

Explanation

Aircraft that have an accident on the aerodrome grounds or in the immediate vicinity can be recovered by us. This service is subject to a fee and requires the conclusion of a recovery contract including a disclaimer. The amount of the fee depends on the time and complexity of the recovery. In any case, you are obliged to clear the operating areas of damaged aircraft immediately without causing any delay or damage.

AVGAS Fuel Card

Explanation

Starting in June 2025, AVGAS refueling at MGL will be managed directly by Flughafengesellschaft Mönchengladbach GmbH.

In addition to credit card payment, we offer the option to apply for an AVGAS fuel card. This option is available exclusively to users who have authorised SEPA direct debit for all airport-related invoices.

Fuel transactions will be recorded to your customer account and debited via SEPA direct debit following invoicing.

The initial issuance and return of the fuel card are free of charge. A processing fee applies in case of loss or damage requiring card replacement.

Storage of aircraft

Explanation

You have the option of parking your aircraft in one of our hangars for a fee. There are two options available to you:

1. Long-term hangar lease agreement

You can for a permanent hire contract with a contractually defined entitlement to parking in one of our halls. This contract is linked to the licence plate number and holder and is not transferable. If you decide in favour of this option, please contact the airport administration to find out the exact terms of the contract.

1. Daily storage

Alternatively, you can also store your aircraft without a contract on the basis of daily storage. The decision on parking is made on a daily basis and depends on the operational circumstances. If storage is not , the regular parking fees will be charged for the day. Please note that in this case no separate notification will be sent and we cannot guarantee a fixed parking space.

The parking and retrieval of the aircraft is carried out exclusively by our operations service. The costs for this are included in the parking fee, provided that the process is related to a flight movement that has been carried out.

Access to or driving on the enclosed airfield area is only to persons and vehicles with a valid permit. In order to obtain this authorisation, an application must be submitted to Flughafengesellschaft Mönchengladbach GmbH. In addition, liability insurance with a minimum cover of 50 million € for vehicles is required. Authorisation is granted by issuing an access token or vehicle vignette and is subject to a fee.
